\$2B in State Surplus

The Time to Invest is Now

As the federal government shutdown reaches the longest in US history and program cuts dominate the headlines, it's falling to Connecticut to decide whether we'll let the bottom 80% of our state bear the brunt — or step up and balance the

playing field.

Governor Lamont recently announced a

\$500 million contingency fund to help soften the blow, but it's not nearly enough. Connecticut currently sits on over \$2 billion in surplus revenue from this year alone, even after reserves were filled up to the legal maximum and all of our additional

long-term debt payments were made. Those excess dollars can — and should — be used to protect residents and the public services we all rely on in the immediate present.

For 8 years, fiscal roadblocks have kept Connecticut from investing in the people who make this state work. These self-imposed restrictions have diverted billions into excess debt pay-

downs and bondholder accounts while schools, hospitals, and social services face staffing shortages and funding cuts.

Now, with federal support vanishing, that approach isn't just unfair — it's dangerous. You don't make extra mortgage payments on a house with a dilapidated roof.

SJM Arbitration Update

Year 1 Award Anticipated in December

CSEA's seven state bargaining units are united in our ongoing demand for fair and honorable contracts. The work and progress made at one table, directly impacts the 34 other tables negotiating a contract right now, allowing workers the opportunity once again to leverage individual power into a strong coordinated movement.


Having not made significant progress in negotiations, our Supervising Judicial Marshals (SJM) bargaining unit—together with our fellow Judicial unions, the Judicial Professionals Employees (JPE) Union, AFT Local 4200-B,

and IBPO Local 73 I—made the strategic decision to press the State into arbitration on just the first-year (2025–2026) core economics. Our goal was clear: to win the same 2.5% General Wage Increase (GWI) plus step that was agreed to by the Connecticut State Police Union. The Judicial Branch acted honorably by working with us to schedule arbitration quickly and focus on this first year.

On day I of that arbitration, we learned that we will be awarded the retroactive 2.5% General Wage Increase (GWI) for the current 2025-2026 fiscal year that we sought. This also includes a step increase and topstep lump sum payments where applicable.

The formal award from the arbitrator won't be issued until December 3, which means that the award

continued from page I won't be taken up by the Connecticut General Assembly until their next regular session which begins in February of 2026. In the meantime, the SJM Council will

focus on negotiations for years 2, 3, and 4 of the contract.

This award will be helpful to our six other state units who have already declared impasse or are still pushing for progress at the table. Some may soon follow toward impasse and arbitration as progress remains slow. We are coordinating our strategies across units to build maximum leverage, and there will soon be opportunities for all members to make their voices heard directly to the Governor. The upcoming special session gives lawmakers a chance to do what Washington won't: act decisively to protect working families. They must dedicate the \$2 billion surplus to an **Emergency Fund** – a smart, immediate investment that would shield residents from cuts to SNAP, Medicaid, childcare, and other essential programs. There are about 75 days between Special Session and General Session, we need enough put aside

now so that we aren't stuck in the same position we've been in this month as elected officials scramble to react to SNAP cuts.

As the special session convenes, CSEA will continue pressing legislators to invest in the people who serve, feed, teach, and care for our communities every day. Because when federal funding disappears, it's working people who hold the line — and they deserve a state ready to stand with them.

2025 Municipal Election Results

82 of 87 Endorsed Candidates Win

CSEA-endorsed candidates triumphed across Connecticut on November 4th, with all but five of our endorsed candidates cruising to victories, including six CSEA members: Swapna Das, Jan Lawrence, Sarah Jones, Warren Packer, John McNamara and Lois Dupointe. This resounding success reinforces what we know: Connecticut stands as a pro-worker, pro-union state.

Municipal elections matter.

The decisions made by local leaders—
on school budgets, staffing public

safety, and essential services—shape our daily lives far more than most people realize. Politics start local, and electing leaders who understand and respect the value of public service sets the foundation for progress at every level of government.

As a reminder, our endorsement process is rigorous and transparent. It begins with candidates reaching out to CSEA for consideration. Only those who actively request endorsement move forward to receive an extensive questionnaire.

Upon submission, candidates participate in interviews conducted collaboratively with our SEIU siblings—SEIU 1199, SEIU 32BJ, 4Cs, and CEUI/MEUI. This nonpartisan process led us to endorse candidates from both major parties this year. The CSEA Legislative Action Committee (LAC) reviews each interview and makes recommendations, which are then brought to the CSEA Executive Council for final approval.

UConn Health & Aetna Medicare Letter Explained

You may have received a recent letter from UConn Health or Aetna regarding UConn Health's participation in Aetna's Medicare Advantage network. We know the language in these notices can be confusing and may have caused unnecessary concern — so we want to provide some

Here's what you need to know:

- These letters are required by federal Medicare rules whenever a provider's contract is within 60 days of expiring — even if negotiations are ongoing and even if no disruption is expected.
- The language in the letters is legally mandated and cannot include important context about state retiree coverage.

-For State of Retirees covered under the State of CT Medicare Plan contracted by Aetna, and not the normal Aetna Medicare plans, this situation is not expected to affect your access to care or your benefits.

Bottom line: You do not need to make any changes to your healthcare providers or coverage. We are confident this will be resolved without any interruption to your care.

The Comptroller's Office will be sending official clarification soon. confirming that your benefits are not impacted. We will share additional updates if needed.

Public Service Loan Forgiveness is a Promise It Must Be Kept

Public Service Loan Forgiveness is not a handout — it's a promise made to the public workers who keep our state running and has a direct impact on the services these workers provide to our communities. Nurses and doctors, teachers and researchers, public safety officers and caretakers, engineers and social workers — all of them chose service over higher private-sector salaries with the understanding that after ten years of public service, their federal student loans would be forgiven.


Now the federal administration is attacking the once bipartisan PSLF promise, threatening the benefit for all of Connecticut's public sector workers. Public sector workers are the people who keep our streets safe and our children fed and our

hospitals running. And just as private sector workers have been let down by broken promises — from the weakening of labor protections to the near-dismantling of the National Labor Relations Board — public sector workers are now facing the same playbook: make a promise, benefit from their labor, then pull the rug out from under them.

Public service workers face uncertainty, ridicule, lower pay and hard work every day. PSLF is a small way to repay them for their sacrifice. Failing to uphold this promise doesn't just hurt workers, it undermines every classroom, clinic, and community that depends on these individuals and services in their everyday lives.

The Hunger Crisis

SNAP Cuts Leaving Tens of Millions Hungry

The Supplemental Nutrition Assistance Program (SNAP) is one of the most effective anti-poverty programs in America, offering targeted assistance to working families, children, seniors, and people with disabilities. In Connecticut, it's not an abstract policy it's a lifeline for hundreds of thousands of our neighbors.

Here's a quick SNAPshot (as of November 2025):

- One out of every five children in Connecticut relies on SNAP
- About 10.6 % of Connecticut's population, or roughly 391,200 people, received SNAP benefits
- Nearly half of all SNAP recipients work full- or part-time jobs, often in lowwage sectors like retail, food service, and home care.
- Over 9,000 veterans in Connecticut rely on SNAP
- The annual cost of SNAP is far less than the

taxes evaded by the top 1 % of Americans each year meaning hunger could be virtually eliminated if the wealthiest paid what they

As the federal government shutdown continues, the Trump Administration has refused to use its authority to fund SNAP and WIC through contingency reserves, the same funds used in past crises to prevent hunger, despite court rulings. Instead, the USDA ran out of funds to pay benefits for roughly 42 million people starting November

This isn't just reckless it's cruel. Parents working full-time could soon be standing in food bank lines. Seniors on fixed incomes might have to choose between groceries and medication. Children — many already facing food insecurity — risk going hungry not because resources

aren't available, but because of political gamesmanship.

Some of our union members rely on SNAP, and many of the people our members serve in their jobs rely on SNAP. This program touches all of us. When politicians target SNAP, they aren't just targeting "someone else." They're targeting one out of ten of our neighbors, family and friends. Hunger is a labor issue. Food security is a public service issue. Ensuring that every family in Connecticut has enough to eat is a fight worth having.

Because no child, no senior, and no worker should go hungry while the rich get richer.

Council 400 President's Corner: Mike O'Brien

PLAN AHEAD

I think we all have seen the above title on a bumper sticker or a bulletin board somewhere. The writer ran out of room before he ran out of letters. A lack of proper planning. Another way of saying it is measure twice, cut once.

I attended Comptroller Scanlon's Forum, "The Future of Retirement: Policy, Planning, Protection" at Quinnipiac University back in September. Council 400 was well represented with several officers and member activists in attendance. Also, our own Bette Marafino was a member of one of the discussion panels, on Social Security of course.

One thing I learned is that only about 50% of private sector workers even have access to a defined contribution plan such as a 401k. The rest would have to rely on private savings programs such as an IRA. That's if they even have the ability to put money aside for retirement.

Of course, I was there to hear what the thoughts are on the future of Social Security. If you are one of our members who took the Council

400 quiz on retirement security at a chapter meeting, then you know the answer to this question: Based on the latest Congressional Budget Office estimate, Social Security benefits will need to be cut by 21% in what year? The answer is 2033. Not all that far off but ask yourself what comes before that? Presidential election years of 2028 and 2032. One of the speakers on the Social Security panel posited that nothing will be done to fix Social Security until the 2032 election year when it would be an impending crisis.

My question is why wait until then? Hence the title of this column. Why not do something now? Why wait for a crisis? I have said many times that I don't understand why the appropriate fix is not in for Social Security already. It is not a Democratic or Republican or even a MAGA issue. It's an American worker issue.

Why do I say crisis? A 21% cut in Social Security benefits may not be a crisis for some but it will be for many families. Also think of it beyond the individual benefit issue. Approximately \$16.4 B in Social Security

benefits come into Connecticut in a year. Think of the impact of the loss of 21% of this (\$3.4B) on the state as a whole and businesses in particular if that amount is no longer able to be spent into our economy. Then multiply that by all 50 states.

I was happy to hear the AARP representative state that cuts to Social Security benefits don't have to be on the table. I know that Congressman Larson agrees with that and has been pushing legislation for years that fixes Social Security for decades to come, actually proposes increased benefits and in order to pay for it, raises the cap on premiums paid so that the people who can most afford it are paying their fair share.

Now I understand brinkmanship and working under a deadline. When writing this column, I do most of it the day or so before it is due. However, my work on a column won't affect the lives of millions of Americans. So I am calling on the leadership of both parties in Congress to come together and get something done that fixes Social Security without cutting much needed

benefits.

As I am finishing this up, it is a rainy Monday and Columbus Day holiday. Good thing it's raining or I might be working on this tomorrow night since it is due on Wednesday!

Since this column will be in the November edition of the CSEA News, I want to wish you all a Happy Thanksgiving. Remember we all do have a lot to be thankful for.



Are We a K-Shaped Economy?

The Rich Get Richer While the Rest of Us Struggle

Economic commentators have been describing today's economy as K-shaped — with one arm rising and the other falling, indicative of a widening wealth gap. Over the past several years, policies have cushioned stock market-heavy households, those whose portfolios outsize some people's entire lifetime earnings. Meanwhile, the majority of Americans have been tightening our belts, stretching groceries one more day just to make it through the month.

In a K-shaped economy, prosperity doesn't lift everyone — it lifts the few. Some sectors and income brackets thrive while the rest struggle to keep pace. The top 10% of earners now account for 50% of consumer spending, and only the top 20% have seen personal spending growth exceed inflation in recent years. In other words, if you're in the bottom 80%, you're likely spending more just to buy the same goods as

before.

The gap isn't limited to spending — it's baked into savings, too. The top 20% of income households now hold over twothirds of all household wealth. These are the families who benefit most from rising stock markets and real estate prices, while millions of working and middleclass Americans are priced out of homeownership, weighed down by debt, and forced to rely on savings that can evaporate with one unexpected bill.


Here in Connecticut, this dynamic is nothing new. We've long talked about the reality of two Connecticuts: one with fully staffed schools, smooth roads, and well-funded public programs — and another where communities fight for scraps. When wealth and consumption are concentrated at the top, public revenue dries up, infrastructure crumbles, and community stability becomes harder to sustain.

But this doesn't have to be

our story. We can enact progressive tax policies that ensure the ultra-wealthy — those reaping record profits and federal tax cuts — contribute their fair share. By reclaiming those lost tax dollars, we can reinvest in the things that make our com-

munities strong: quality public education, safe roads, reliable services, and the public workforce that keeps it all running.

Because the economy should work for everyone — not just those at the top of the "K."
